Pongal Celebrates Agricultural **Prosperity with Great Zest!**

A harvest festival, Pongal is an occasion for the people to thank the Sun God for agricultural abundance and seek his blessings for the year ahead

HOUGH there are many colourful festivals to celebrate and enjoy in India, few festivals beat the festive temperament of harvest festivals such as Pongal. CEREMONIAL PONGAL DISH

This unique festival is named after a sweet concoction called "Pongal", prepared from the new harvest of rice boiled in milk with jaggery (raw sugar). In Tamil, the word "Pongal" translates into "to boil, overflow" or "spill over", signifying abundance and prosperity. To prepare a Pongal dish, sometimes people also add cardamom, raisins, green gram (split), and cashew nuts, making it extra flavourful. Other ingredients that can be added to this flavoursome concoction are coconut and ghee. Once it is prepared, it is first offered to the gods and goddesses, followed sometimes with an

Some people also prepare other versions of this sweet dish such as the salty and savoury Ven Pongal. To make Ven Pongal, "rice is mixed with moong daal and cooked with ghee, cashew nuts,

The Pongal dish is cooked in a clay pot in a sun-lit porch or courtyard, as it is dedicated to the Sun God. The clay pot is beautifully garlanded with leaves or flow-

artworks called kolam. This traditional ritual dish is either prepared at home or in community gatherings at temples or village open spaces. Free kitchen services are prepared by volunteers at temples for all those who gather, with portions of the sweet Pongal dish being distributed as prasadam (offerings).


