Ltd commenced vide order dated 25/03/2022 of Hon'ble NCLT, Kolkata and Mr. Tuhin Kumar Chatterjee was appointed as the IRP. However the process could not commence as Mr. Tuhin Kumar Chatterjee unfortunately passed away. Given the circumstance Mr. Amit Patni was appointed as the IRP vide order dated 19/05/2022 of the Hon'ble NCLT, Kolkata to conduct the CIRP. This order dated 19/05/2022 was received by Mr. Amit Patni on 23/05/2022. In regard to the aforesaid mentioned facts and circumstances the IRP has been advised to file an application with the Adjudicating Authority seeking exclusion of time period from 25/03/2022 to 22/05/2022. The dates mentioned in the table above are subject to the exclusion of time period being granted by the Hon'ble Adjudicating Authority.</p>
