

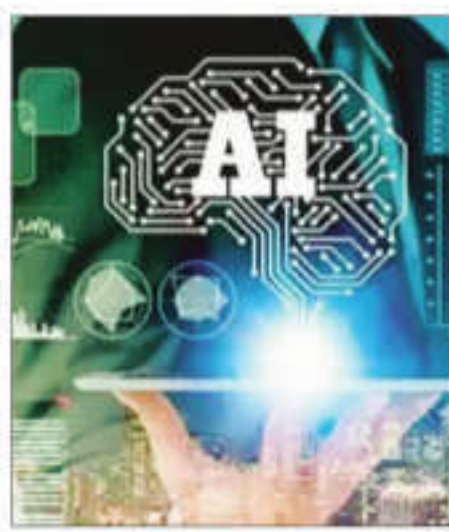
China may use AI to influence Lok Sabha elections: Microsoft

CHINA MAY USE content generated through artificial intelligence (AI) to try and affect the Lok Sabha polls in India, along with elections happening in countries such as the US and South Korea, a report released by Microsoft Friday said.

Microsoft said that "at a minimum" China will create and distribute through social media AI-generated content that "benefits their positions in these high-profile elections". And while the chances of such content affecting election results remain low, the company said that China's increasing experimentation in augmenting memes, videos, and audio will likely continue, "and may prove more effective down the line". These are among the Microsoft Threat Intelligence insights in a report titled 'Same targets, new playbooks: East Asia threat actors employ unique methods' published by the Microsoft Threat Analysis Center (MTAC).

China had already attempted an AI-generated disinformation campaign in the Taiwan presidential election in January, Microsoft said in the report. This, the company said, was the first time it had seen a state-backed entity using AI-made content in an bid to influence a foreign election. But, China's targets could go far beyond Taiwan this year, Microsoft warned. The company said that it has observed "several notable cyber and influence trends from China and North Korea since June 2023 that demonstrate not only doubling down on familiar targets, but also



attempts to use more sophisticated influence techniques to achieve their goals".

Microsoft claimed that Chinese cyber actors broadly selected three target areas over the last seven months: one set of Chinese actors extensively targeted entities across the South Pacific Islands, and a second set of Chinese activity continued a streak of cyberattacks against regional adversaries in the South China Sea region. A third set of Chinese actors compromised the US defence industrial base, the company said.

"Chinese influence campaigns continued to refine AI-generated or AI-enhanced content. The influence actors behind these campaigns have shown a willingness to both amplify AI-generated media that benefits their strategic narratives, as well as create their own video, memes, and audio content," Microsoft said.

China-based threat actors continued to target entities related to China's economic and military interests in and around the South China Sea and compromised government and telecommunications entities in the Association of Southeast Asian Nations, as per Microsoft.

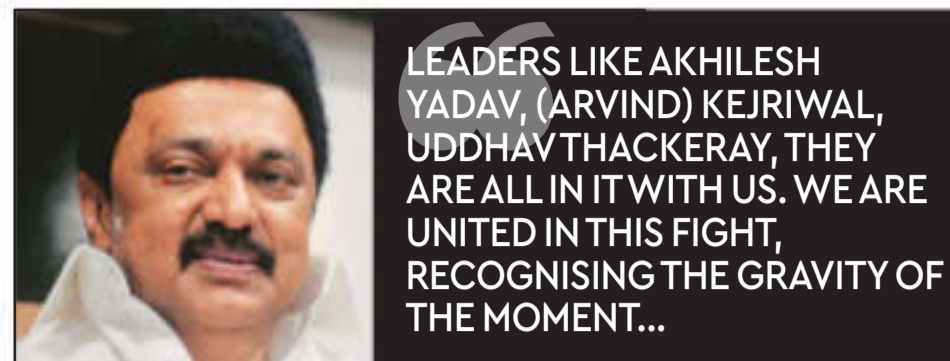
'OPPOSITION HAS A STRONG TEAM' 'These polls do-or-die battle for democracy'

AS TAMIL NADU gears up to vote for the Lok Sabha elections in a fortnight, as part of the first phase on April 19, chief minister M K Stalin, who is leading the INDIA bloc in the state, says: "It feels like we are in the midst of a second struggle for Independence. "It's all about defending the

core of India: democracy, secularism and our pluralistic society, not to mention the principle of federalism... from what I would frankly call fascist forces."

In an interview with *The Indian Express* at his Chennai residence, the DMK chief said that if the BJP's main weapon is projecting Prime Minister Narendra Modi as "a larger-than-life" persona, the Oppo-



sition has on its side "a strong team". "Leaders like Akhilesh Yadav, (Arvind) Kejriwal,

Uddhav Thackeray, they are all in it with us. We are united in this fight, recognising the

gravity of the moment... In the coming elections, a dynamic young leader like Rahul Gandhi is set to dismantle that cultivated image of Modi and the broader RSS narrative," Stalin said, calling it "a do-or-die battle for Indian democracy itself". Referring to report on cases against Opposition leaders getting stalled or delayed after they moved to the BJP, Stalin said: "After a decade in

power, rather than showcasing their achievements, the Modi government is busy dredging up the past, pointing fingers at stalwarts like Pandit Nehru and Indira Gandhi. And what's their main agenda now? Seemingly, keeping the Opposition in check, using every tool at their disposal, with even the Election Commission looking the other way as Opposition leaders face arrest."

Elgar Parishad case: SC bail to Shoma Sen

IN A RELIEF to academic-activist Shoma Kanti Sen, arrested in June 2018 in connection with the Elgar Parishad-Maoist links case, the Supreme Court Friday granted her bail while taking cognisance of the "composite effect" of the delay in framing charges coupled with her prolonged detention. The SC imposed several conditions on the 66-year-old Sen, including that she shall keep the location status (GPS) of her mobile phone active round the clock while under bail and her phone shall be paired with that of the investigating officer of the NIA to enable him, at any given time, to identify her exact location.

A bench of Justices Anirudha Bose and Augustine George Masih also directed Sen shall inform the IO about her place of residence, will use only one mobile number and not leave Maharashtra without the leave of special court. It noted that any form of deprivation of liberty results in breach of Article 21 of the Constitution and must be justified on the ground of being reasonable and following a just and fair procedure. Observing that section 43D(5) of the UAPA would not be applicable in Sen's case, the bench said, "... taking cognisance of composite effect of delay in framing charge, period of detention undergone

by her, the nature of allegations against her vis-a-vis the materials available before this court at this stage in addition to her age and medical condition, we do not think she ought to be denied the privilege of being enlarged on bail".

The SC also set aside the January 17 last year order of the Bombay HC which had disposed of her bail application with liberty to approach the trial court for a fresh application for bail.

It noted that Additional Solicitor General KM Nataraj, who appeared for the NIA, had stated that at present the agency would not require her custody for further investigation.

SC stays HC order scrapping Madarsa Education Act

IN A BREATHER to about 1.7 million madarsa students, the Supreme Court on Friday stayed an order of the Allahabad High Court that scrapped the Uttar Pradesh Board of Madarsa Education Act, 2004 calling it 'unconstitutional' and violative of the principle of secularism.

rect that establishment of board will breach secularism," the bench, also comprising Justices JB Pardiwala and Manoj Misra, said. The top court said the HC 'prima facie' misconstrued the provisions of the Madarsa Act, which does not provide for any religious instruction.

"The finding of the court that the very establishment of the board would violate secularism appears to conflate Madarsa education with the regulatory powers of the board. If the concern was to ensure that the students receive quality education, the remedy would not lie in striking down the Madarsa Act but in issuing directions to ensure that they are not deprived of quality education," the bench said.
